

#### Section 19 of FY 2025 GAA Special Provisions

The implementation of the ESC and SHS Voucher Programs, as well as other programs of Government Assistance and Subsidies, including the conduct of research toward the attainment of the objectives of government assistance to private education, shall be subject to the issuance of policies and guidelines by DepEd and shall be managed jointly by DepEd and the Private Education Assistance Committee (PEAC) with the exception of the Joint Delivery Voucher Program which shall be solely managed by DepEd.








#### FY GAA 2024 Budget (PHP 39.00B)

### Implementation of the FY 2025 GAA Special Provision

#### **Special Provision (SP) in FY 2025 GAA**

(a) xxx for the implementation of the Educational Service Contracting (ESC) Program in private junior high schools. In the selection of grantees, priority shall be given to LEARNERS FROM CONGESTED PUBLIC SCHOOLS AND LEARNERS WHO COME FROM LOW-INCOME HOUSEHOLDS. The ESC Program shall adopt a performance-based accreditation or certification for participating private junior high schools;

#### **GASS-ODMD and PEAC-NS actions:**

- GASS and PEAC to emphasize the Special Provisions through national orientations to be attended by the ESC Participating Schools
- GASS, through PEAC, to facilitate the submission of documentation from ESC participating schools on the conduct of ESC grantees selection activities.
- GASS is currently proposing an amendment on the selection process of ESC grantees





### Validation of Billing Statements at the DepEd Central Office (CO)

A second layer of verification is conducted at the Central Office to identify discrepancies between billing statements and the Learner Information System (LIS). Payments to schools will be withheld until all identified issues are resolved.

To avoid payment delays and ensure smooth validation at the CO level, participating schools must:

- 1. Ensure that the learner is already enrolled in the LIS prior to encoding in the Information Management System (IMS) or Voucher Management System (VMS).
- 2. Assure that the Learner Reference Number (LRN) in the LIS matches the LRN encoded in the VMS/IMS.
- 3. Resolve any issues involving multiple LRNs assigned to a learner.

**Take note:** Subsidies for learners not enrolled in the school during the LIS validation period will **not be released**.





### Frequently Encountered Issues during LIS Validation



#### **Duplicate LRN entries**

- Multiple billing entries using the same Learner Reference Number (LRN) across schools or within a school.
  - Human Error/Mistake during Encoding:
    - Failure to search the LIS database
    - Incorrect encoding of learner's basic information
    - Lack of complete documentation

#### **Unmatched Learner Data**

- Discrepancies between learner names, birthdates, or LRNs in LIS vs. IMS/VMS.
  - Invalid Basic Information: Incorrect Name, Incorrect Date of Birth And Incorrect Gender
  - Transfer Process Issues
    - Unconfirmed Transfers
    - Learner Enrolling in Multiple Schools







### Frequently Encountered Issues during LIS Validation

#### **Unenrolled in LIS During Validation Period**

- Learners not tagged as officially enrolled in the LIS within the defined validation window.
  - Dropped Out/No Longer Participating in School
  - Transfer Issues
  - Encoding Delay/Error
  - Erroneous Data
  - Pending LRN Issuance/Correction



#### <u>Incorrect School Assignment</u>

- Learner encoded in IMS/VMS under a different school than reflected in LIS.
  - Improper Transfer-Out/Transfer-In:
    - Previous School Didn't Transfer Out
    - New School Creates New LRN
    - Transfer Dispute
  - Mistaken Encoding/Human Error



### Frequently Encountered Issues during LIS Validation

#### **Late LIS Encoding**

 Schools encoding learner information after the LIS validation cut-off, causing mismatch or missing data.

### Publication of the GAS Program Beneficiaries on the DepEd's Official Website

- The publication complies with Section 28, Article II of the 1987 Constitution, which mandates that the State adopts and implements a policy of full public disclosure for all its transactions involving public interest.
- The publication shall only be limited to the full names of program beneficiaries
- The GAS program-participating schools shall collect and secure the Data Privacy Notice beginning SY 2025-2026





### Teachers' Salary Subsidy (TSS) Increase

- From current subsidy amounting to Php18,000 to proposed subsidy amounting to Php24,000.
- The State Assistance Council (SAC) resolution regarding the increase has been signed during the Ceremonial Signing on July 31, 2025.
