Accountability

The **obligation** and **willingness** of individuals and institutions (such as teachers, school leaders, schools, and education systems)


to accept responsibility for educational outcomes and actions,

and to be **answerable** for fulfilling their **defined roles and responsibilities**.




Accountability is a shared responsibility among stakeholders.


Going **beyond compliance**, it is about **ownership, responsiveness and continuous improvement**.





Based on PISA 2018 results, **roughly 60% of private school learners have below minimum proficiency levels** in reading (59.04%), mathematics (62.46%), and science (56.65%).

Accountability takes many forms.

Deconcentrate/shift authority from DepEd Central Office to Regions, Divisions, Schools



Strengthen partnerships with LGUs and the private sector on education service delivery



Advocate for responsiveness, local solutions, and shared responsibility

To strengthen accountability in our education system, decentralization is key.

Elements of Decentralization	Definition	Examples
Capacity	Having the competence and ability to fulfill roles successfully	PEAC and NEAP programs to train and develop leaders, teaching and non-teaching staff, and program implementers
Authority	Empowered to make decisions to achieve target results	School-based Management, LGU partnerships
Resources	Having financial, human, and organizational support, and other enablers	Higher MOOE, more non-teaching staff, equitable allocation and sufficient funding to succeed
Accountability	Having ownership over the results, decisions, and resources	Link to learning outcomes, addressing input gaps, budget execution
Transparency	Promoting broad stakeholder sharing of information, engaging active participation	CSO and community engagement, reporting plans, budgets, decisions, results

What's in it for private schools?

- **Private school autonomy:**
 - Levels of decision-making
 - Budgets for capital expenditures and operating expenses
 - Flexibility in curriculum and instruction
- **Market-based accountability among schools**
- **Public-private complementarity in the local education ecosystem**
 - Participate in local governance and local fora
 - Impact of decentralization on regulatory oversight and partnerships

How can we strengthen accountability for better learning outcomes?

- ✓ Clarify **shared roles and responsibilities** across all stakeholders
- ✓ Continuously **build capacity** with targeted training
- ✓ **Empower local authorities** with autonomy and necessary oversight
- ✓ Ensure **adequate resources are prioritized** to marginalized areas
- ✓ Use **balanced accountability measures** combining compliance and results
- ✓ Institute **mechanisms for continuous improvement**
- ✓ Promote **transparency and meaningful participation** throughout the system

Call to action

- Accountability is a collective effort vital for meaningful education reform. **Hold ourselves to account as much as we do others.**
- **Learn more about and advocate for decentralization** as a form of shared governance to improve trust, ownership, and achievement of outcomes
- Invite **all** stakeholders to **commit to supporting these mechanisms**
